## NOTICE OF PUBLIC HEARING

The National Finance Authority (the "NFA") has received a request from St. Luke's University Health Network (the "Network") to issue its revenue bonds, in one or more series or sub-series, as part of a plan of finance, in an aggregate stated principal amount not to exceed \$150,000,000 (the "2021B Bonds"), the proceeds of which will be used to provide original financing (through the direct financing, reimbursement, or refinancing of existing taxable debt) of certain projects (collectively, the "St. Luke's Health Network Projects") for the benefit of the following entities: St. Luke's Health Network, Inc. (the "Network"), St. Luke's Hospital of Bethlehem, Pennsylvania ("Bethlehem"), St. Luke's Hospital – Anderson Campus ("Anderson"), St. Luke's Hospital – Monroe Campus ("Monroe"), St. Luke's Quakertown Hospital ("Quakertown"), and Carbon-Schuylkill Community Hospital, Inc. d/b/a St. Luke's Miners Memorial Hospital ("Miners" and, together with the Network, Anderson, Bethlehem, Monroe and Quakertown, the "Borrowers"). Each of the Borrowers is a Pennsylvania non-profit corporation which is exempt from federal income tax as an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code").

In connection with the Network's request and in accordance with Section 147(f) of the Code, the NFA will hold a public hearing under RSA 162-S on October 18, 2021, commencing at 12:30 p.m. or as soon thereafter as the matter can be heard, at 2 Pillsbury Street, Suite 201, Concord, New Hampshire 03301, regarding the St. Luke's Health Network Projects, their nature and locations and the proposed issuance of the 2021B Bonds. Interested persons wishing to express their views on the St. Luke's Health Network Projects and the proposed issuance of revenue bonds by the NFA to finance the St. Luke's Health Network Projects will be given the opportunity to do so at the public hearing or may, prior to the time of the public hearing, submit their views by e-mail to the NFA at john@nfabonds.com.

The St. Luke's Health Network Projects consist of hospital and medical facilities at the following locations in Northampton County, Pennsylvania, Lehigh County, Pennsylvania, Monroe County, Pennsylvania, Montgomery County, Pennsylvania, Bucks County, Pennsylvania, and Carbon County, Pennsylvania and in the estimated maximum principal amount as set forth below:

The St. Luke's Health Network Projects will be initially owned and/or operated by one or more of the Borrowers.

The 2021B Bonds shall not be a debt, liability or obligation of the NFA, the Business Finance Authority of the State of New Hampshire, the State of New Hampshire, or of any political subdivision thereof, but shall be payable solely from payments derived from the Network and its affiliates and from other security, if any, furnished by the Network or its affiliates with respect to the 2021B Bonds. If issued, the 2021B Bonds are intended to be issued as "qualified 501(c)(3) bonds" as defined in Section 145 of the Code for hospital and medical facilities.

This notice is published in accordance with the Code and the regulations promulgated thereunder.
